Continue on Forest Road for approx. 2kms and turn right on King St E (21N) and continue on to Townsend Line and turn right (East) and go to Northville Road/ County Rd. 9 and turn left and make a quick right at Ravenswood Line and turn left at Northville Road/County Rd. 79 and continue 5kms to Lakeshore Road/21N toward and turn right – follow to the Pinery Park entrance and follow signs to the store where the lunch will be served. The entire route will be marked with signage.
